(一)商品檢驗法第五十九條:應施檢驗商品之報驗義務人,違反商品檢驗法第十一條或第十二條有關標示之規定, 經主管機關限期改正而屆期不改正者,處新臺幣十萬元以上一百萬元以下罰鍰。

應施檢驗商品之報驗義務人,為不實之標示者,處新臺幣十五萬元以上一百五十萬元以下罰鍰。

- (二)商品檢驗法第六十條:應施檢驗商品之報驗義務人,有下列情形之一者,處新臺幣二十萬元以上二百萬元以下 罰鍰:
  - 1. 違反第六條規定,將未符合檢驗規定之商品運出廠場或輸出入或進入市場者。
  - 2. 違反第四十五條第二項重新聲明之規定者。
  - 3.未依第四十七條第一款辦理,或第四十七條第二款虛偽不實之情形者。

有前項情形且經檢驗不符合者,處新臺幣二十五萬元以上二百五十萬元以下罰鍰。

- (三)商品檢驗法第六十一條:應施檢驗商品之報驗義務人,違反本法之規定致損害消費者生命、身體、健康或有重 大損害之虞者,處新臺幣七十五萬元以上七百五十萬元以下罰鍰。
- (四)商品檢驗法第六十二條:違反第五十一條第二項不得規避、妨礙或拒絕封存、檢查、調查或檢驗之規定者,處新臺幣十五萬元以上一百五十萬元以下罰鍰,並得按次連續處罰及強制執行檢查、調查或檢驗。
- (五)商品檢驗法第六十三條:有前四條情形之一者,主管機關並得命令限期停止輸出入、生產、製造、陳列或銷售。報驗義務人違反主管機關依前項規定所發命令者,處新臺幣二十五萬元以上二百五十萬元以下罰鍰,並得按次連續處罰。

經銷者違反主管機關依第一項規定所發命令者,處新臺幣一萬元以上十萬元以下罰鍰,並得按次連續處罰。 違反主管機關依第一項主管機關規定限期停止輸出入、生產、製造、陳列或銷售之商品流入市場者,主管機關 應通知報驗義務人限期改善、回收或銷燬;屆期不改善、回收或銷燬者,處新臺幣十五萬元以上一百五十萬元以下罰鍰,並得按次連續處罰。

違反前項規定,主管機關並得扣留、沒入、銷燬該流入市場之商品或採取其他必要之措施。

(六)商品檢驗法第六十四條:依本法所處之罰鍰,經限期繳納,屆期不繳納者,依法移送強制執行。
